

Barwon South West Telehealth Website - Terms of Use

This website is established and maintained by The Barwon South West Telehealth Program. These Terms of Use set out the terms and conditions of a contract between you and Barwon South West Telehealth governing your access to, and use of, the Site (defined below). By visiting, registering for, or using, this Site, you agree to be bound by and abide by these Terms of Use.

These Terms of Use, include, and are supplemented by, other terms and conditions contained within the Site that are more specific to the use of particular parts of this Site. In the event of any inconsistency the terms and conditions specific to a part of the Site prevail.

1. Use of the Site

1.1. You must:

- 1.1.1. comply with these Terms of Use at all times while using the Site;
- 1.1.2. not use, or knowingly permit another person to use, the Site if you (or they) are not eligible to do so;
- 1.1.3. where applicable:
 - 1.1.3.1. ensure that your contact and other details submitted to the Health Service or stored on the Site are current and accurate; and monitor any electronic system or address designated by you for the purpose of receiving communications (Barwon South West Telehealth will not be liable for any delay or failure by you to do so);

 - 2.2.2.3. Barwon South West Telehealth could reasonable consider as inappropriate.
- 2.3. Barwon South West Telehealth may remove any content submitted by you which Barwon South West Telehealth (in its absolute discretion) considers in breach of these terms. While Barwon South West Telehealth will monitor the content submitted on any of its social media sites, it may not monitor all content at all times. - 4.2. - 4.5.7. if you suspect your computer has been affected by harmful code you should contact your IT service provider or anti-virus vendor.

- 5.1.1.
